1. Introduction


The Western Cape economy is relatively open, as it significantly engages in international trade. Economic cooperation and trade offer several benefits to an economy. International trade enhances efficiency, promotes competition and encourages the transfer of knowledge. Through specialisation and efficient use of resources, international trade can assist in boosting the productive capacity of an economy, which can have a positive impact on employment. It must, however, be emphasised that openness makes the local economy vulnerable to external shocks.

The rest of this paper discusses the Western Cape's key statistics and trends in international trade with the major regions of the world.

2. An overview of the Western Cape's trade across different regions


Figure 1: Share of exports

More than two-thirds of the Western Cape's exports are destined for Africa and Europe. As shown in Figure 1, Africa accounted for approximately 38% and 35% of exports in the 2011-2015 and 2016-2020 periods respectively, making the continent the largest destination for the Western Cape's exports. The recently concluded African Continental Free Trade Area (AfCFTA) will help to further boost trade on the continent. Europe, the region with the second largest market share of the Western Cape's exports, accounted for about 30% of the province's total exports during the 2016-2020 period. Asia (18%) occupied the third position, followed by the Americas (10%) over the same period.


Figure 2: Share of imports

Figure 2 shows the share of the Western Cape's imports across the different regions of the world. The figure shows that more than 50% of the Western Cape's imports come from Asia. During the 2016-2020 period, about 52% of the value of imported products into the Western Cape was sourced from Asia. Europe (21%) and Africa (20%) were respectively the second and third largest source regions for the Western Cape's imports over the same period.

2.1 Africa

As already emphasised, Africa is one of the Western Cape's key trading partners. That said, the growth rate of exports from the province to the African continent decreased from 5.5% in 2018 to -0.7% in 2019. The Western Cape's exports to Africa declined further by -16% in 2020, the lowest growth rate recorded over the past decade. Imports from the continent to the Western Cape also experienced a negative growth rate (-44%) in 2020, the highest decline since 2010.

The top three exported products from the Western Cape to Africa, between 2010 and 2020, were petroleum oils and oils obtained from bituminous minerals (other than crude); flat-rolled products of iron or non-alloy steel; and cigars, cheroots, cigarillos and cigarettes. These three products together accounted for approximately


29% of total exports from the province to the rest of Africa during the period under consideration. In terms of imports, crude petroleum oils and oils obtained from bituminous minerals alone constituted more than three-quaters of the province's total imports from Africa.



2.2 Europe

Europe is the second largest export region for the Western Cape. In 2020, the province's exports to Europe increased significantly by 29% (the highest growth rate over the past decade), after a -4% decline (the lowest recorded growth rate between 2010 and 2020) in the previous year. On the other hand, the growth rate of imports from Europe to the Western Cape declined from approximately 5% in 2019 to -4% in 2020.







As shown in Table 2, the majority of the Western Cape's top ten exported products to Europe are agricultural and agri-processed products. The Western Cape's top three exported products to Europe over the past decade were wine of fresh grapes (16%): fresh or dried citrus fruit (14%); and fresh or dried grapes (12%). Moreover, the province's top three imported products from Europe during the 2010-2020 period were petroleum oils and oils obtained from bituminous minerals (other than crude); undenatured ethyl alcohol; and electric generating sets and rotary converters.

2.3 Asia

After two years of negative growth, the Western Cape's exports to Asia increased by approximately 26% in 2020, which was the highest growth rate since 2012. In constrast, the growth rate of imports from Asia to the province declined by about -6% in 2020, after an initial decrease from approximately 20% in 2018 to 3% in 2019. This contributed to a fall in the region's share of imports to the Western Cape from about 56% in the 2011-2015 period to 52% during the 2016-2020 period.



Table 3 contains the top ten Western Cape products that are exported to and imported from Asia. The top ten exported products from the Western Cape to Asia are dominated by agricultural and agri-processed products (8 out of 10). Fresh or dried citrus; fresh apples, pears and quinces; and petroleum oils and oils obtained from bituminous minerals (other than crude) were the top three exported products from the province to Asia between 2010 and 2020. Protroleum oils and oils from bituminous minerals (both crude and non-crude) accounted for 57% of the Western Cape's imports from Asia during the same period.

2.4 Americas

The highest growth rate (44%) of exports from the Western Cape to the Americas during the period under review was recorded in 2014. The Western Cape's exports to North and South America increased by about 16% in 2020. On the contrary, the growth rate of the province's imports from the Americas declined from 8% in 2019 to 0.5% in 2020.

As shown in Table 4, wine of fresh grapes (including fortified wines) was the Western Cape's top exported product to the Americas from 2010 to 2020, followed by fresh or dried citrus fruit, and articles of jewellery. Furthermore, the top three products imported by the Western Cape from North and South America during the 2010-2020 period were petroleum oils and oils obtained from bituminous minerals (crude); iron ores and concentrates; and petroleum oils and oils obtained from bituminous minerals (other than crude).



2.5 Oceania

The Oceania region accounts for about 1.5% of the Western Cape's total exports and 0.5% of the province's total imports. The growth rate of exports from the Western Cape to the Oceania region was approximately 11% in 2020, the highest it has been since 2016. Likewise, the value of imports from Oceania to the province increased by about 28% in 2020, which is the highest growth rate recorded during the 2010-2020 period.

Figure 7: Growth rates of exports and imports to and from the Oceania region, 2010-2020






In Table 5, fruits, nuts and other edible parts of plants; fish fillets and other fish meat; and beauty or make-up preparations were identified as the top three products that the Western Cape exported to the Oceania region from 2010 to 2020. On the other hand, the top imported products from the Oceania region to the province were frozen fish; uncoated kraft paper and paperboard; and edible offal of bovine animals, swine, sheep, goats, horses, asses, mules or hinnies.

2.6 Antarctica

The value of trade between the Western Cape and Antarctica is relatively small. Only 0.02% of the Western Cape's exports are attributable to the Antarctica region. In 2020, exports to Antarctica increased by 23% whereas the growth rate of imports was approximately -90%.

Petroleum oils and oils obtained from bituminous minerals (23%) were the top Western Cape products exported to the Antarctica region between 2010 and 2020 as shown in Table 6. Likewise, the top three products imported by the province from Antarctica were containers (24%); ferrous waste and scrap (23%); and edible offal of bovine animals, swine, sheep, goats, horses, asses, mules or hinnies (22%).

3. Conclusion

The Western Cape is an open economy that actively participates in world trade. A significant proportion of the province's total exports goes to Africa and Europe, the former being its largest exporting partner. Moreover, petroleum oils and oils obtained from bituminous minerals (other than crude) were the top products exported from the province to the rest of the African continent, whereas wine of fresh grapes was the top Western Cape product exported to Europe between 2010 and 2020. Furthermore, more than half of the Western Cape's imports was made up of goods originating from Asia, China being the leading source market.
